


Face Coverings Guidelines



If available, and controls such as barriers to block or create physical distance between the employee and the customer are not feasible, employers should provide face masks to workers in the grocery industry with regular close contact with the public, such as cashiers, pharmacy workers, and baggers. Employers should train and encourage workers to wear the face covering of their choice voluntarily while at work.

Announcement re: Limited Retail Reopening (5/13/20)

Temperature

Recommended as a best practice for retail employers: screen employees and customers with a no-contact thermometer and do not permit entry to those with a temperature greater than 100.4F.

Health Screen

Required. All employers must screen employees for symptoms before they enter the workplace each day, verbally or with a written or text/app-based questionnaire.

Face Coverings Guidelines

Requirement

All employers must provide all employees with face coverings and require they be used in the workplace.

All "essential businesses" operating as "retail space" (such as grocery and hardware stores) with a building footprint of more than 50,000 sq.ft., and all restaurants, must ensure that all employees wear face coverings or medical grade masks. As of May 11, all smaller, essential retailers must also require employees to wear face coverings or medical grade masks.

County Status and Phase Information

Temperature

<u>Recommended</u>. Employers should consider regular health checks (e.g., temperature and respiratory symptom screening) or symptom self-report of employees, if job-related and consistent with business necessity.

Personal care services employers should consider temperature checks for clients

Health Screen

<u>Recommended</u>. Employers should consider regular health checks (e.g., temperature and respiratory symptom screening) or symptom self-report of employees, if job-related and consistent with business necessity.

<u>Personal care services employers</u> must contact clients prior to appointments to screen them for symptoms.

Face Coverings Guidelines

Requirement

All employers may encourage or require employee use of cloth or disposable face coverings as indicated by sector-specific guidance. If employers require use of cloth face coverings, employers must provide cloth or disposable face coverings for employees.

Retail employers and restaurant, bar, and other food and beverage establishments must require all employees to wear employer-provided cloth or disposable face coverings.

<u>Personal care services</u> employees must wear face coverings (and may consider medical grade masks) when providing client services, and are recommended to provide face coverings for clients.

Guidance for Screening Employees

Temperature

Health Screen

No requirement

Requirement

Required. Restaurant/bar employees, movie theater and live performance venue employees must be screened for symptoms of illness before each shift.

Required. Gym employees must be screened for symptoms of illness before each shift.

Required. Personal care services employees must be screened for symptoms of illness before each shift.

Generally recommended for other employers.

Face Coverings Guidelines



Required for gym employees. Required for personal care services employees and patrons.

Grocery store and retail personnel are <u>recommended</u> to follow CDC guidance regarding wearing face coverings while at work. Customers should be encouraged to wear face coverings while in the store.
